Nathaniel's Hope celebrates and serves children and adults with all types of disabilities, referred to as VIPs (Individuals with Value and Incredible Purpose), while educating, equipping, and encouraging communities and churches to provide meaningful support to individuals with disabilities and their families. All programs and services are provided free of charge to participating VIPs and their families. The Organization currently serves more than 16,000 VIP children and adults throughout the year.

Nathaniel's Hope operates several core programs designed to provide respite, community engagement, practical assistance, and inclusive opportunities for individuals with disabilities and their caregivers.

Teams Commissioned for Christ International ("TCCI") is a DBA of Nathaniel's Hope. TCCI is a missions organization whose mission is to "share the love of God with those who know Him not, and with those who want to know Him more." The Organization offers short-term mission opportunities for individuals and teams, serving as a bridge between the local church and the national church in Guatemala. Short-term teams serve on medical, construction, children's ministry, training and education, evangelism, and feeding teams that assist in the benevolent care of the indigenous people. TCCI also provides basic support services for field missionaries. The Organization's missionaries provide educational and leadership training to help nationals establish and strengthen the local church. The work has now expanded within Asia.

In response to the growing needs of adults with disabilities, the Organization is actively developing HOPETOWN, an inclusive live, work, and play community designed to serve individuals with disabilities and their families. The Organization has secured approximately 380 acres for the project and plans additional expansion. HOPETOWN is envisioned as a live, work and play residential community environment providing employment opportunities, vocational and life skills training, medical and therapy services, respite care, recreation, agricultural experiences, social enterprises, and community gathering spaces designed to foster inclusion, friendship, independence, and long-term support for individuals with disabilities.
